Gateway to Equity Award, 2016

The Allentown Branch of AAUW will present the 2016 Gateway to Equity Award to the Allentown School District Foundation at the Interbranch luncheon on Saturday, March 12. The vision of this foundation is to enrich the education for Allentown School District students through funds raised in various ways. Their mission is to encourage, promote and support innovative educational experiences for students. Donations support art, history, literacy, physical fitness, social studies, and STEM programs. The foundation also has funded Teacher Innovation Grants, in which teachers in the district may apply for grants to support a teaching idea or program. Scholarships to college bound seniors at William Allen and Dieruff high schools are funded by the foundation, as are scholarships for various summer activities for students in the district. The following bits and pieces come to us from our national organization under the heading AAUW Washington Update:

Friday, February 5, 2016 was the 23rd anniversary of the FMLA, also known as the Family Medial Leave Act, which provides eligible workers up to 12 weeks of unpaid job-protected leave for medical or parental reasons. AAUW and Lobby Corps volunteers worked hard to get this law passed.

In spite of this success AAUW feels there is still more work to be done to ensure that this leave becomes paid leave. Many people do not use this leave time because they can't afford time off without a paycheck. AAUW is now urging Congress to enact the Family and Medical Insurance Leave Act (FAMILY) for paid parental leave policies. This Act would create a self-sustaining fund which employers and employees would contribute to so that people have a paycheck and are still able to take the medical leave necessary for family members. As we all

know, the majority of people who must take leave are women who are caregivers for their children, spouses and parents. Please call or write to your representative to sponsor this bill.

AAUW Cheer of the Week

Viewing and Discussion of the film A Place at the Table

A Place at the Table is a 2012 documentary film concerning hunger in the United States.

As of 2012, about 50 million Americans were food insecure. This was approximately 1 in 6 of the overall population, with the proportion of children facing food insecurity even higher at about 1 in 4. One in every two children receive federal food assistance.

A Place at the Table shows how hunger poses serious economic, social, and cultural implications for the United States, and that the problem can be solved once and for all, if the American public decides – as they have in the past – that making healthy food available and affordable is in everyone's best interest. LAF-Supported Plaintiffs Win Settlement

In January 2016, the plaintiffs in the LAF-supported case *Moshak v. University of Tennessee* successfully settled their Title IX lawsuit against the university. As part of the settlement, the university will pay more than \$1 million. Jennifer Moshak, Heather Mason, and Collin Schlosser are former employees of the University of Tennessee's women's athletic department. In 2012, they filed suit against the university, alleging sex discrimination and unlawful retaliation under Title VII of the Civil Rights Act of 1964, Title IX of the Education Amendments of 1972, and the Equal Pay Act of 1963. The plaintiffs claim they were unlawfully discriminated against and eventually forced out of their positions during a university-led merger

of the men's and women's athletic departments. Gender discrimination in sports remains a significant problem, for athletes as well as for coaches and administrators who support women's athletics. The Moshak plaintiffs shared a professional commitment to women's athletics at a university that has a rich history of excellence in women's sports. Their allegations show just how pervasive discrimination against women's sports and women athletes can be. AAUW is thrilled for the plaintiffs and proud to have supported the case.

AAUW Signs On to Support Women's Reproductive Health

AAUW joined an amicus brief in the U.S. Supreme Court case *Whole Women's Health v. Cole*, challenging a Texas state law that imposes significant restrictions on clinics that provide abortion care. The law would have the effect of closing the majority of the abortion care clinics in Texas. AAUW supports choice in the determination of one's reproductive life and increased access to health care and family planning services.

Turning Point of Lehigh Valley is a safe place where victims of abuse and their children can find refuge and services. Over 5,000 women and children from Lehigh and Northampton counties are helped each year. Turning Point's mission is three-fold:
