### Let's Read Math ..... Would you like to join??

It's hard to believe, but **Let's Read Math** is celebrating its 10 year anniversary as a community outreach program. It seems like only yesterday that a few hardy souls ventured out to hear Dr. Claire Passantino of the Makefield Area AAUW present this unique program. Returning home, it was decided we would collaborate with our sisters from the Allentown Branch to present the program to elementary students (grades 2-4) in both of our school districts. Tapping in to the

expertise of both math and elementary teachers in our branches, interactive lesson plans were developed that combined reading a children's book that fosters the joy of reading with a fun math lesson. These lessons reinforce the math standards taught at each grade level and build positive attitudes toward math. And then the fun started... lining up all the "props" to make the lessons fun and exciting for these young students. During the ten years I can't even begin to imagine how many thousands of marshmallows and toothpicks we have purchased.

Our "school year" usually runs from mid-October to February but not every week. Each lesson lasts approximately one hour and we usually do two or three lessons in one day. And one of the best perks... if the schedule allows we enjoy great comradery at a local restaurant for lunch.

There is no long term commitment to the program. If you want to join, your name is added to the email list and you come when you can. We work in teams of 5 to 8 in a classroom. And believe me; you don't have to know anything about math or teaching to be part of this group. You might hand out name tags, help children with their costumes for a play, or supervise a small group making geometric shapes out of all those marshmallows mentioned earlier. If you have raised your own children or are now enjoying your own grandchildren, you more than qualify for this group. Our motto is, "Many hands make light work."

Over the years, we have reached well over 2000 children. With the cutbacks to funding in public education, teachers are thrilled to have this program come to their schools. But the best part is seeing the children "light up" when they "get" a math concept. And boy do they remember us. I returned to one school months later to read to a class for Dr. Seuss's Birthday and as I walked down the hall I was greeted by a group of students out in the hall with, "Hi, Marshmallow Lady." I have been called many things in my career in education, but this one was definitely one I will always remember and cherish.

One of the things we always lamented in our teaching careers was that we never knew if we "reached" our students in a meaningful way. But I am certain this program is helping to "reach" these youngsters and instill in them a love a math and reading AND the importance of being lifelong learners.

This is a great group of gals who enjoy fun and fellowship while working with children. ## Public Policy

### Lesley Loiko, Public Policy Chair

At the August meeting of the Lehigh Valley Women's Advocacy Coalition we learned how the Women's Law Project is working on recommendations for a #MeToo policy agenda in Pennsylvania.

The mission of the Women's Law Project is to create a more just and equitable society by advancing the rights and status of all women throughout their lives. To this end, we engage in high-impact litigation, advocacy, and education.

They are urging our general assembly to promptly vote 7 House bills into law. They all apply to all types of harassment and discrimination including disability, handicap, national origin, ancestry, age religion, color or race. The bills are House Bill #1965, #2280, #2282, #2283, #2284, #2286, and #2475. You can search for these on the web.

An example of what these are trying to remedy by passing laws is HB #2283 which requires employers to post fair practices notices in the workplace that includes descriptions and examples of unlawful acts of discrimination, harassment, and retaliation.

# AAUW-PA Eastern District Meeting SAVE THE DATE November 3, 2018

On November 3, 2018, the AAUW Doylestown and Lansdale Branches will co-host the Eastern District meeting program featuring the Honorable Judge Andrea Hudak Duffy of Montgomery Township District Court. Judge Duffy will share with us her mission to save lives ravaged by the opioid addiction crisis in her township and throughout Pennsylvania. She will discuss her formation of the *Drug Addiction Resource Alliance* (DARA); a collective of local and Montgomery County agencies and facilities involved in different aspects of drug treatment. Quoted in *The Reporter* newspaper at the time she formed the alliance, Judge Duffy stated, "We have to save lives, and I truly believe we can start to conquer things one patient at a time, one issue at a time, and maybe we can make a difference in our little corner of the world." ### AAUW Mourns the Loss of LAF Founder Katherine "Kappy" Eaton

Katherine "Kappy" Eaton passed away in August at age 94. Eaton was well known throughout AAUW and valued greatly within her AAUW member state of Oregon. During her longstanding commitment to the organization, she served as the executive vice president of AAUW and started the Legal Advocacy Fund during the 1981 AAUW National Convention. Since then LAF has provided millions of dollars to balance the scales of justice for people working toward gender equity through the legal system. Eaton's legacy will live on through the hundreds of landmark cases LAF has supported, such as Wal-Mart v. Dukes and Cioca v. Rumsfeld, as well as ongoing cases with the potential to change the future legal landscape, such as Rizo v. Fresno County Office of Education. Thank you, Kappy Eaton, for your visionary leadership.

### Legal Advocacy in Action — AAUW Signs on to Amicus Brief

### Moussouris v. Microsoft

Moussouris v. Microsoft is an important case currently before the United States Court of Appeals for the Ninth Circuit. This case is seeking to clarify Federal Civil Procedure Rule 23 for class certification standards, which courts have been weakening over time, limiting women's ability to pursue joint action challenging systemic discrimination. This case has been brought on behalf of a class of current and former female Microsoft employees who have been discriminated against under Microsoft's pay and promotion systems. The plaintiffs in the case asserted that Microsoft systematically undervalued female technical employees in their "calibration" or evaluation process because female employees received, on average, lower rankings despite equal or better performance. They argued that Microsoft has a "continuing policy, pattern, and practice of sex discrimination against female employees in technical and engineering roles ... with respect to performance evaluations, pay promotions, and other terms and conditions of employment." The plaintiffs Katherine Moussouris and Holly Muenchow moved to certify a class of employees, representing approximately 8,000 current and former female Microsoft employees. Judge James Robart of the United States District Court for the Western District of Washington found that the plaintiffs could not establish a class pursuant to the requirements of Rule 23 because the plaintiffs' claims did not demonstrate a common question to be resolved on behalf of the putative class, the claims were not typical of the class members, and the plaintiffs were not adequate representatives of absent class members. He issued an order denying certification on June 25, 2018. The plaintiffs now seek review before the Ninth Circuit Court of Appeals. AAUW joined an amicus brief in this case because we advocate for equitable access and advancement in employment, including vigorous enforcement of employment discrimination statutes and the right to challenge discriminatory employment practices through class actions. This case misconstrued Title VII, muddied the evidentiary standards for establishing systemic disparate treatment and disparate impact discrimination, and made numerous errors in its interpretation of the class action rules. This case would make it much more difficult to get employment discrimination classes certified. The amicus brief we joined clarified the legal standards for bringing class actions set out in Wal-Mart v. Dukes, a previous LAFsupported case. The case is not yet scheduled for oral argument.
