

Minutes: Minutes of Feb 9, 2021 meeting were reviewed. Motion to accept by Peggy and second by Bev. Passed.

Finance Report: Only activity was \$500 sent to PA State AAUW for NCCWSL. Susan was contacted by them and they reported that only 9 students had registered so far (the conference will be virtual) so our \$500 isn't needed. Susan will ask that the money be returned to the branch. Susan made a motion to that effect with second by Bev. Passed.

Membership and Dues: Dues increase of \$3 is going into effect July 1. Branch renewal notices will be sent out by Susan around March 15. Susan made a motion for the branch to cover the \$3 increase in dues for all paying members for this upcoming dues cycle. Karen seconded the motion and it passed. Susan will write something up for both the dues notice and the newsletter to tell our members.

Linda shared with us a program she is involved with called Teach Rwanda. She will contact them about sharing information about this program at a future branch meeting. May's Annual Luncheon is on hold due to the pandemic.

Newsletter/Yearbook: Bev noticed that she was not included as a member of the A Team in the newsletter. She will contact Kathy Osmond to put her name on the list. Newsletter submissions for April issue are due to Kathy O by March 15.

Website: Linda reports that the website is updated.

Public Policy: No report.

Happy Spring Everyone!

True signs of Spring are the mailings and petitions we're asked to sign, for the upcoming Primary Election. May 18, 2021 is Primary Day in PA.

If you wish to get a mail-in ballot you must request it by calling the Lehigh County Election Office at: 610 782 3194 or go on-line to VotesPA. Remember that you can only vote for candidates who are in the party in which you are registered for the Primary elections only. In the General election in the Fall you can vote for anyone regardless of their party. As I understand it you must apply each year for a mail-in ballot. There is no reason to request one if you plan to vote in person.

Lehigh County Judge of Common Pleas seems to be the most active race because 3 current judges are retiring. We have already met 2 candidates at markets while we were out and about. They were cross filed and informed us that we can sign 3 petitions because there are 3 positions open. Allentown's mayoral race looks interesting as do the County Commissioners races and local school board races.

A question arose at our A-team meeting about school testing during the pandemic. The U.S. Dept. of Education has decreed that testing for this school year may not be cancelled but that states may have flexibility for scheduling the tests. As I understand it, Governor Wolf is allowing testing for the school year 2020-2021 to be held in the fall of 2021.

Another concern of Education policy is that the Title IX rules that were reset under Secretary Betsy DeVos regarding sexual assaults and harassment on campuses will be reversed under our new Secretary of Education Miguel Cardona. The Rules revised under DeVos favored assaulters over the victims. The newest rules will revert back to favoring the victims, but will take a while to become effective.


