A reminder to all that Primary Day is May 18. The last day to request a mail-in ballot is May 11. You can do so by calling the Lehigh County Election Office at 610 782 2021 or go online to VotesPa.com. The instructions should tell you the mail-in deadline. I mailed my request in about a month ago, received an email acknowledging their receipt of it but have not received the ballot itself yet.

Just before sitting down to write, today, I read the article in the Morning Call about the new and expanded DaVinci Science Center being built in Allentown near the PPL building. Among the many exhibits there will be a 10,000 sq. ft. STEAM education center. THE FIGHT FOR FAIR SCHOOL FUNDING

For a generation, Pennsylvania's legislative leaders have refused to live up to their constitutional responsibility to fairly fund public schools so that all students, not just those from certain zip codes, are equipped with the tools and skills they need.

A group of school districts, parents, and organizations from across the Commonwealth have been <u>challenging</u> the <u>Pennsylvania General Assembly in court since 2014</u> for creating a school funding system where the students who need the most, get the least, because of where they live. And now, the case to #FundOurSchoolsPA is moving closer to trial.

Following a new order from Commonwealth Court, students are on track to have their day in court this September.

Friday, April 2nd, Parents, teachers, school leaders, and attorneys from Education Law Center-PA the Public Interest Law Center held a virtual press conference, where they shared what this trial could mean for our students and the future of our Commonwealth.
